WiseTech Global upgrades FY22 guidance

WiseTech Global Limited (WiseTech or the Company) today upgrades its FY22 guidance, last provided to the market on 23 February 2022.

FY22 revenue is expected to be at the top end of the \$600m-\$635m guided range and the expected FY22 EBITDA range is increased to \$310m-\$320m from \$275m-\$295m, reflecting strong top line growth and cost efficiencies ahead of expectations.

WiseTech Founder and CEO, Richard White said, "We are upgrading our FY22 guidance, with our performance reflecting the resilience of the WiseTech business model and strategy through the cycle. Our product led approach and focus on our 3P strategy has enabled us to continue to deliver strong top line growth and drive significant operating leverage. We look forward to updating the market further at our full year results."

The Company will release its full year audited statutory results on 24 August 2022. Financial information included in this guidance update is unaudited and remains subject to further review and finalization.
