SETTLEMENT OF JMC GROUP ACQUISITION

Real-time software company Vection Technologies Ltd (**ASX:VR1**)(**Vection Technologies**, **Vection** or the **Company**) is pleased to announce the successful completion of its acquisition of JMC Group Srl (**JMC**), as previously announced on 15 June, 5 July and 30 July 2021.

Highlights:

- JMC Acquisition has successfully completed on 3 August 2021
- The acquisition is immediately value accretive Combined Group would deliver revenues exceeding \$10M (based on FY20 unaudited financials)
- All scrip deal at A\$0.10 per share, represents a premium to current share price and demonstrates vendor's long term commitment to Vection
- Consideration shares to be escrowed for 18 months
- Company fully funded to accelerate its global distribution strategy following this acquisition
- CEO to receive aggressive performance based remuneration, aligned with the Company's overarching growth strategy
- Management to host an investor conference call today, Wednesday 4 August 2021, at 12pm AEST to provide an update of the Company's business strategy and financial performance

Overview:

Vection is pleased to confirm the completion of the acquisition of JMC, representing a further step in the Company's verticalization and M&A strategy, maintaining minimal dilution for shareholders, while gaining significant size to enable further aggressive growth across geographies and verticals, supported by over \$10M in revenue in FY20¹.

Total purchase consideration is €4 million (being \$6,391,230 at the agreed exchange rate of AUD\$:EUR€ for the financial year dating 1 July 2020 to 30 June 2021 of 0.6258583) at \$0.10 per share. Pursuant to the Agreement, Vection has issued 63,912,230 fully paid ordinary shares under its Listing Rule 7.1 capacity. The consideration shares issued are subject to voluntary escrow for 18 months from 3 August 2021. An Appendix 2A follows this announcement.

Vection has entered into an agreement with Mr Jacopo Merli to appoint him as JMC's CEO from today. This agreement includes an offer made pursuant to Vection's Employee Incentive Performance Rights Plan for the issue of performance rights which will convert into fully paid ordinary shares on the achievement of audited revenue and/or audited EBITDA targets for JMC, aligned with the Company's overarching global growth strategy.

The key terms of the performance rights will be as follows:

- Class A Performance Rights will convert into an aggregate of \$159,780.57 worth of Ordinary Shares upon JMC achieving ~\\$8.8M1 in audited revenue or \\$0.5M1 in audited EBITDA in the applicable 2021 fiscal year.²
- Class B Performance Rights will convert into an aggregate of \$159,780.57 worth of Ordinary b. Shares upon JMC achieving ~\$14.2M1 in audited revenue or \$1.5M1 in audited EBITDA in the applicable 2022 fiscal year.³
- Class C Performance Rights will convert into an aggregate of \$159,780.57 worth of Ordinary Shares upon JMC achieving ~\$20.8M1 in audited revenue or \$3M1 in audited EBITDA in the applicable 2023 fiscal year.4

The performance rights are expected to be issued under the Vection's Employee Incentive Performance Rights Plan to Mr Merli within 3 months. It is expected that, if all the final performance milestones are achieved, and the performance rights are converted at the floor conversion price, a maximum of 4,793,417 shares will be issued across 3 years.
